Pre-history

There is no such thing as pre-history or prehistoric animals or life. The Bible is the history of the world from its beginning.

God:

Gen 1: God existed before time (start of universe/all matter), matter and space. So, God existed outside of space, time and matter. God is eternal i.e. having no need for time and existing without a beginning or end of time.

Creation/evolution:

these two are **incongruent** because one says that;

- -Theistic evolutionists say there is a God who created the big bang and then let everything after that evolve on its own over millions of years. Genesis disagrees it says each day was a new creation act not an evolution.
- -Man was created from an accident
- -God said he breathed into a pile of dirt and it came to life.

Flat earth or spherical earth:

There is greater evidence of a spherical earth than a flat earth. Flat earthers cannot produce the edge of the earth or a bottom of the earth nor the enclosed dome nor explain why we can travel in both directions of the globe and return to the original spot we started from.

In the beginning,

there are many theories about this phrase. It is believed that Chapter is a second beginning buts its just a detailed explanation of chapter one. The word "WAS", also stimulated much debate also. One such theory is that there was an older earth with people (pre-Adamic race) and the devil lied there after he sinned and corrupted it and God had to destroy it and God had to recreate the second Earth. A closer examination will reveal that there was no land only water in the beginning.

The first light:

Since the creation of light an evening duration passed then a morning time passed when they ended that was the same time as the total length of time which light had existed since it was created. We believe this especial from the evidence of day 4

<u>FUNCTION</u>: it caused a division or separation from the darkness.

PURPOSE-What was the purpose of the light?
(1) It illuminated the earth and (2) it indicated the number of days. (3) It counted time. this light shone over the face of the deep/abyss
It is no longer visible suggesting it had stopped shining or may have served its purpose which

END OF FIRST LIGHT: Where is the first light today. Day 4 gives a clue. The sun and the moon were created for a purpose and were given authority to take over or to rule over the lighting of the Earth. No other light has that authority to shine upon the face of the earth from day 4 onward. Therefore, this infers that the Sun and moon brought and end to the first light function and purpose and probably implying it no longer existed and its purpose was temporary.

NO LONGER VISIBLE: all light is not visible.

We cannot say it was white like the sun and moon. But if it caused the effect of morning then it was probably visible. Anyway the light is not visible which implies it no longer exists.

Young earth:

1-If a day was 1 mil yrs the sun shone for about ½ mil yrs without any night which would have killed all life with its heat and then then their would be night for ½ mil yrs killing everything with its coldness, darkness and lack of sunlight.
2-If Adam was 1 million or 1000 years old on day 6 and his age would have been counted in 1000s of years so he would be 9 million or 935,000 years and not 935 years old. Likewise, his children including Noah and his sons who lived after the flood may be millions of years old and alive today but couldn't because a mil years have not come yet since the flood.

- 2- Man's age: Noah's son Shem lived at the time of Abraham and Abraham's years were counted in the same timeline as Shem's. Shem's age was counted in the same time as Noah. Noah's age was counted in the same time as Adam
- **3- Days 4, 5 & 6** The Sun and moon shone for the same time duration as morning and evening

in days 1,2,3. We can easily calculate the length of days 1,2,3.

4- Days 1-6: If days 1-6 are the same in duration due to the evening & morning then they were all 24 hr days. On the fourth day we realize that there was only one change. And that change was the first light seem to have ended in function and purpose and probably no longer existed. Then the sun and the moon we're given authority to take over or to rule no other light has that authority to shine upon the face of the earth other than the moon and the Sun, therefore sun & the moon came into existence and the time they shone for coincided with the evening and the morning which already existed before them. Now when we look today at the sun and the moon and the morning and the evening we see how long morning and evening took and that is 24 hours therefore if the evening and morning has remained the same since day one then we know how long days 1-3 of creation took. The Evening and morning remain the original evidence from day one of creation. So we have two reliable instruments that were from the

beginning that measured the time of creation, which are the sun and moon. So we know how long the days of creation were.

Man, woman & humankind:

The first man and woman were created on day 6 Gen 1:26 while Gen 2: is a detailing of the account not a new man and new woman. Pre-Adamic race? The Idea comes from reading Gen 2 as another creation of man and woman. Dinosaurs: Job 40:15-24 Behemoth & 41:1, 19-21 Leviathan. The word is not in the O.T. because its Greek and it became popular after biologist and paleontologist, Sir Richard Owen coined the term "Dinosauria" in 1841. The word dinosaur derives from two greek words (deinos) "terrible, powerful, wondrous" + (sauros) "lizard". Since 1841 archeological finds of thousands of giant animal creatures have been found and recorded. Some resembling Behemoth. Cave drawings almost all over the world demonstrate man living with giant land animals which means they are not hundreads of millions of years old. Even the Carbon testing they used refutes millions of years. Carbon cannot exist in a dead creature for more than 10,000-20,000 years. Carbon has been found in many Dinosaurs this proves they are only thousands not millions of years.

Classification of creatures.

It is based on similarities that Carl Linnaeus decided to put together. He his own invented taxonomy method. Someone else would have had a different matrix or scheme. E.g. classifying by who they are able to breed with would produce a different scheme. If it was based on colour of skin it would be different also, for example the color scan of a chimpanzee, monkey or ape is white if you shaved all of the Apes and chimpanzees and look at the human beings on the planet you may think that they were brothers. Chimpanzees have tails and apes do not. Classifying by tails would have a different outcome.

God's classification system was easy. It was based on humans and beasts. Beasts were further classified by their own kind which means those animals which could interbreed with each other.

Marriage:

Gen 2:24 The first marriage is instituted on earth by God and it was done by God. It was a between man and woman and for man and woman. Did God ordain same sex marriage or heterosexual marriage.

Sin:

Gen 3 Sin's first introduced to earth/humans. Death as a result of sin, a spiritual partition separates man from God & later a physical one in the temple. The partition was removed by Jesus after his death and man is reconciled to God Heb 7.

The apple/fruit:

One reason is that the Latin for evil is *malum* and the Latin word for apple is also *mālum* (just with a long-a). In the fourth century A.D., the word *malum* appeared in the Latin Vulgate translation of Genesis in the phrase 'the tree of knowledge of good and evil'. From that time on people began to associate the apple with the fruit which Eve ate. The Bible does not identify the fruit of the tree by name.

Serpent:

We can actually link various verses in the bible that would indicate that the devil was in the garden and had either influence the serpent to communicate or he was actually in the form of a serpent.

 If it was serpent and not the actual devil but only the devil's influence on him then why was the serpent species punished because of the devil's use of him.

2. The serpent: The devil was not the actual serpent but the influencer such as with the king of Tyre, Judas, the possessed boy and the pigs in the legion incident. The devil's actual legs were not removed and crawled on the ground. That was an actual physical snake with physical legs. The devil is a spirit being (was an angel) that does not have physical legs that when removed he falls to the ground.

Let us compare him to Adonizedek a king of an actual earthly place called Jerusalem (" יְרוּשֶׁלִים 'Yruwshalayim (yer-oo- shaw-lah'-yim) [rarely] 1. (meaning) founded peaceful.

(Josh 10:1 [KJV]) Now it came to pass, when Adonizedek king of Jerusalem (Yerushalayim) had heard how Joshua had taken Ai, and had utterly destroyed it; as he had done to Jericho and her king, so he had done to Ai and her king; and how the inhabitants of Gibeon had made peace

Jews were forced to leave their homeland, that returning Jews left Babylonia at various times, and that some Jews chose to remain in Babylonia. 586 to about 516 (the year when the rebuilt Temple was dedicated in Jerusalem). Elders supervised the Jewish communities, and Ezekiel was one of several prophets during the Babylon captivity who kept alive the hope of one day returning home. Daniels was another prophet in Babylon. This was possibly also the period when synagogues were first established, for the Jews observed the Sabbath and religious holidays, practiced circumcision, and substituted prayers for former ritual sacrifices in the Temple. The degree to which the Jews looked upon Cyrus the Great as their benefactor and a servant of their God is reflected at several points in the Hebrew Bible—e.g., at Isaiah 45:1–3, where he is actually called God's anointed".

New leadership after Babylon

In 539 BCE the Persians conquered Babylon, and in 537 BCE Cyrus the Great allowed Jews to return to Judea and rebuild the Temple. He did not, however, allow the restoration of the Judean monarchy, which left the Judean priests as the dominant authority. Without the constraining power of the monarchy, the authority of the Temple in civic life was amplified. It was around this time that the Sadducee party emerged as the party of priests and allied elites. It seemed that although the priests controlled the rituals of the Temple, the scribes and sages, later called rabbis (Hebrew word for Teacher/master), dominated the study of the Torah, they taught at the houses of study believed to be introduced in Ezra's time.

New leadership under the Hellenists (Greeks)

The Hellenistic period of Jewish history began when Alexander the Great conquered Persia in 332 BCE. The rift between the priests and the sages developed during this time, when Jews

REASON & FAITH APOLOGETICS

faced new political and cultural struggles. After Alexander's death in 323 BCE. Judea was ruled by the Egyptian-Hellenic Ptolemies until 198 BCE, when the Syrian-Hellenic Seleucid Empire, under Antiochus III, seized control. Then, in 167 BCE, the Seleucid king Antiochus IV invaded Judea, entered the Temple, and stripped it of money and ceremonial objects. He imposed a program of forced Hellenization, requiring Jews to abandon their own laws and customs, thus precipitating the Maccabean Revolt, Jerusalem was liberated in 165 BCE and the Temple was restored. In 141 BCE an assembly of priests and others affirmed Simon Maccabeus as high priest and leader, in effect establishing the Hasmonean dynasty.

Pharisees

The Pharisee ("separatist") party emerged largely out of the group of scribes and sages. The word is believed to be from the Hebrew and Aramaic Parush while 'Pharisee' is a Greek word. This group resisted Helenisation (Greek culture,

While their rivals, the **Pharisees, claimed the authority of piety and learning, the Sadducees claimed that of birth and social and economic position**. During the long period of the two parties struggle which

REASON & FAITH APOLOGETICS

lasted until the Romans destruction of Jerusalem in 70 AD the Sadducees dominated the Temple and its priesthood.

The Sadducees refused to go beyond the written Torah (first five books of the Bible) and thus, unlike the Pharisees, denied the immortality of the soul, bodily resurrection after death, and the existence of angelic spirits. For the Sadducees, the Oral Law, *i.e.*, the vast body of post-biblical Jewish legal traditions meant next to nothing. By contrast, the Pharisees revered the Torah but further claimed that oral tradition was part and parcel of Mosaic Law".

The LXX, being very close to the Masoretic Text (AD 916) we have today, helped to confirm the reliability of the transmission of the Scriptures through the years.
